We offer a wide range of play experiences, positively promoting and respecting choices made by children. **All** children are welcomed and valued for who and what they are as a unique individual.

Children attend **Speke Venny** on an Open Access basis; this means that they are **free to come and go as they choose**, during opening hours.

Speke Adventure Playground offers provision for children aged **8-16 years of age**.

Speke Adventure Playground is a part of the Liverpool Youth Service funded through Liverpool City Council. We are on the Ofsted Voluntary register as an Open Access provider for children of 6 and above.
